MSA FINDINGS

On June 19, 2023, during each of the 10-minute clock periods between minute ending 10:51 and 17:30, the average MW delivered by the MEG1 asset varied outside the allowable dispatch variance. Section 203.4 of the ISO rules states, in part:

3(1) A pool participant must not, during generating asset steady state, vary the average MW it delivers from a generating source asset in any 10-minute clock period outside the allowable dispatch variance.

The MSA is satisfied that the conduct was a contravention of section 203.4 of the ISO rules.
