EVENT DETAILS

On January 7, 2016 for the hour ending (HE) 07 settlement period, the sum of the e-tag import volumes at the start of the HE 07 settlement interval was 25 MW however, the declared available capability (AC) of the MOMT import asset as stated two hours prior to the start of the HE 07 settlement interval was 0 MW. ISO rule 203.6 indicates that a pool participant must submit e-tags for an energy interchange transaction such that the sum of the e-tag volumes agrees with the available capability (AC) of the asset as stated two hours prior to the start of the settlement interval.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.6.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO e-tag and available capability data for MOMT for January 7, 2016.
2. AESO information request issued to Morgan Stanley Capital Group Inc. dated March 15, 2016.
3. Morgan Stanley Capital Group Inc.'s response to the AESO information request dated April 7, 2016.
4. Referral from the AESO to the MSA dated April 12, 2016.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
