EVENT DETAILS

On March 1, 2017 at approximately 10:26, an offer was submitted for asset SHBC to import 170 MW in settlement period hour ending (HE) 15 on March 1, 2017. The e-tag for this settlement period was curtailed to 0 MW at approximately 10:48, however no MW restatement was submitted to revise the import offer accordingly for HE 15. Subsection 6(4) of ISO rule section 203.6 indicates that if the transmission service is curtailed by any transmission service provider or the ISO, the pool participant must submit as applicable an energy restatement or an ancillary services restatement.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.6.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

- 1. AESO energy offer and e-tag data for SHBC for March 1, 2017.
- 2. Shell Energy North America (Canada) Inc.'s self-report to the MSA dated March 9, 2017.

NOTICE
