### CAREER OPPORTUNITY

The MSA is looking to recruit a specialist focused on Alberta Reliability Standards enforcement. The title and compensation of the position offered would depend on the experience and qualifications of the applicant. The position will report to the Director, Enforcement and be part of the MSA Enforcement unit. The MSA Enforcement unit is responsible for investigation and enforcement of all applicable electricity and natural gas legislation,<sup>1</sup> the Alberta Reliability Standards, the Independent System Operator's rules, and Alberta Utilities Commission (Commission) rules and orders.

The successful candidate will have the following responsibilities:

- Review and assess events and information relating to suspected contraventions of Alberta Reliability Standards, direct experts when necessary, provide recommendations to management on enforcement outcomes, and prepare enforcement dispositions.
- Review and assess mitigation plans and proposed mitigation activities and provide feedback regarding whether the plan is likely to mitigate the issue.
- Prepare for and participate in enforcement proceedings at the Commission, which may include drafting application materials, working with legal counsel and experts, and representing the MSA as a witness.
- Liaise with counterparts at the Alberta Electric System Operator, the Commission, the Western Electricity Coordinating Council, and market participant organizations to identify and resolve issues.
- Provide enforcement expertise in relation to a wide range of MSA activities, including on investigation and enforcement matters, regular public reporting, the setting of corporate goals, and mentorship and training. This may be done by supporting the work of colleagues, including editing and commenting on written materials, or as the lead or sole staff person assigned to a file.

• Assist, guide, mentor, and train MSA staff and consultants to perform complex enforcement assignments.

The successful candidate will work individually and as part of teams to support the MSA's enforcement mandate. They will be expected to develop and execute analytical frameworks, methodologies, and work plans that are appropriate to their assigned tasks and to present and actively seek feedback regarding the results and implications of their work. They will also be expected to assist, guide, and train others to perform complex assignments. Active project management and the ability to prioritize competing demands will be essential for success in the position.

The annual base salary for an Advisor begins at \$152,000. The annual base salary range for a Senior Analyst begins at \$115,000.

## QUALIFICATIONS

- Bachelor's or Master's degree relating to engineering, power systems, information systems, information security, computer science, or other quantitative discipline.
- 8 to 15 years professional experience in a compliance, audit, technical, or quantitative role relating to power system operations, cyber security, planning, modelling, protection and control, or risk management.
- Experience with Alberta Reliability Standards or NERC Reliability Standards is a significant asset.
- Direct knowledge of the interconnected electric system in Alberta is an asset.
- Demonstrated ability to evaluate complex data to test hypotheses, apply and adapt frameworks, evaluate results, and draw and present conclusions.
- Strong written and oral communications skills, including the ability to effectively present information to colleagues, management, industry professionals, and public groups, including writing reports and making presentations.
- Advanced Microsoft Office skills are essential.
- Ability to work effectively individually and on teams and under inflexible time constraints.
