## **MSA FINDINGS**

From November 8, 2022 to March 31, 2023 there were numerous instances identified in which the Automated Dispatch Messaging System (ADaMS) account associated with CYP1 was logged out. Section 502.4 of the ISO rules states, in part:

4(1) All Automated Dispatch and Messaging system and voice communication systems under this section 502.4 must be continuously operational twenty four (24) hours a day, seven (7) days a week.

The MSA is satisfied that the conduct was a contravention of section 502.4 of the ISO rules.

## NOTICE
