MSA FINDINGS

On September 23, 2023, during the hour-ending 12, an energy restatement was not submitted for HAL1 to reflect its AC. This resulted in the facility generating and delivering energy to the Alberta interconnected electric system without receiving a dispatch from the AESO.

Section 203.4 of the ISO rules states, in part:

2(1) A **pool participant** may only deliver energy to the **interconnected electric system** pursuant to a **dispatch** or a **directive** the **ISO** issues.

The MSA is satisfied that the conduct was a contravention of section 203.4 of the ISO rules.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5.1 of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
