MSA FINDINGS			
<p>On March 9, 2024, at approximately 12:08, the EMP1 asset experienced an operational deviation that lasted for more than 20 minutes; however, an available capability restatement was not submitted. Section 203.4 of the ISO rules states in part:</p> <p style="padding-left: 40px;">5(1) A pool participant must, if an operational deviation extends for 20 minutes or longer, submit an available capability restatement or MW restatement for the generating source asset that represents the operational capability of the generating source asset and must do so no later than 20 minutes after the commencement of the operational deviation.</p> <p>The MSA is satisfied that the event was a contravention of section 203.4 of the ISO rules.</p>
