Enmax Power Corporation contravened requirement R15.A1 of COM-001-AB-3 on June 23, 2024, as it failed to have sufficient backup power supply to ensure that its backup voice communication capability, in its control room site, was capable of remaining operational for a minimum of 8 hours in the event of an extended power outage of its main power supply for its backup voice communication capability.

Requirement R15.A1 of COM-001-AB-3 states:

Each Responsible Entity shall, where its backup voice communication capability is a satellite telephone service or utility orderwire service, have sufficient backup power supply to ensure that its backup voice communication capability, in its control room site, is capable of remaining operational for a minimum of 8 hours in the event of an extended power outage of its main power supply for its backup voice communication capability.

The MSA is satisfied that the conduct was a contravention of Reliability Standard COM-001-AB-3, requirement R15.A1.
