EVENT DETAILS

On January 6, 2016 for the hour ending (HE) 20 settlement period, the declared available capability (AC) was 295 MW as stated two hours prior to the start of the settlement interval. Subsequently, MOMT received a MATL ATC allocation of 180 MW and consequently had e-tag quantities at the start of the settlement interval of 180 MW. No subsequent restatement of AC was submitted to the Alberta Electric System Operator (AESO) to align AC for MOMT with the sum of e-tag quantities for HE 20. ISO rule 203.6 indicates that if a pool participant is unable to procure all or a portion of the requested transmission service for an energy interchange transaction or the transmission service for an energy interchange transaction is curtailed after procurement either by any transmission service provider or the ISO, the pool participant must submit a restatement of available capability.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.6.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO e-tag and available capability data for MOMT for January 6, 2016.
2. AESO information request issued to Morgan Stanley Capital Group Inc. dated March 15, 2016.
3. Morgan Stanley Capital Group Inc.'s response to the AESO information request dated April 15, 2016.
4. Referral from the AESO to the MSA dated April 25, 2016.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
