## **EVENT DETAILS**

On March 15, 2017 at approximately 23:17, an offer was submitted for asset SHBC to import 50 MW in settlement period hour ending (HE) 06 on March 16, 2017. The e-tag for this transaction was curtailed to 0 MW at approximately 01:42 on March 16, 2017, however no energy restatement was submitted to revise the import offer accordingly for HE 06. Subsection 6(4) of ISO rule section 203.6 indicates that if the transmission service is curtailed by any transmission service provider or the ISO, the pool participant must submit as applicable an energy restatement or an ancillary services restatement.

#### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.6.

The material facts relied upon by the MSA include the following:

- 1. AESO energy offer and e-tag data for SHBC for March 15 and 16, 2017.
- 2. Shell Energy North America (Canada) Inc.'s self-report to the MSA dated April 14, 2017.

### NOTICE
