#### **EVENT DETAILS**

On August 9, 2017 the e-tag export volume for export asset SHXB during the HE 01 settlement interval was 100 MW. However, SHXB's bid prior to the start of the HE 01 settlement interval (submitted at 06:52 on August 8, 2017) was for 250 MW. Section 203.6 of the ISO rules indicates that an export bid should correspond to the scheduled interchange transaction. Subsection 5(1) of ISO rule 203.6 states:

Notwithstanding subsection 3.5.2 of the ISO rules, Submission Timing, a pool participant with an import or export energy interchange transaction must submit through the Energy Trading System the import offer or export bid for the interchange transaction, as applicable, no later than two (2) hours prior to the start of the settlement interval in order for the interchange transaction to be included in the energy market merit order.

### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 203.6.

### **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. E-tag data and AESO export bid data for SHXB for August 9, 2017.
- 2. Self-report submitted by Shell Energy North America (Canada) Inc. to the MSA dated August 25, 2017.
