EVENT DETAILS

At approximately 19:46 on May 4, 2017, the DAI1 generating asset's available capability (AC) was restated to 0 MW following a plant outage. However, DAI1 was dispatched for 10 MW of spinning reserve beginning at 00:00 on May 5, 2017 until approximately 06:27 when its ancillary services offer was restated to 0 MW. From 00:00 until 06:27 on May 5, 2017, DAI1 was not able to meet the spinning reserve requirements set out in ISO rule section 205.5. Subsection 3(4) of section 205.3 of the ISO rules states:

A pool participant that submits an offer must, as soon as reasonably practicable, submit a restatement to represent the operating state of the pool asset if:

- (a) the pool asset is no longer able to deliver the MW set out in the offer; or
- (b) the pool participant is not able to meet the requirements set out in section 205.4 of the ISO rules, Regulating Reserve Technical Requirements and Performance Standards, section 205.5 of the ISO rules, Spinning Reserve Technical Requirements and Performance Standards or section 205.6 of the ISO rules, Supplemental Reserve Technical Requirements and Performance Standards, as applicable.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.3.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO dispatch, available capability and ancillary services offer data for DAI1 for May 4 and 5, 2017.
2. AESO information request issued to Daishowa-Marubeni International Ltd. dated August 24, 2017.
3. Daishowa-Marubeni International Ltd.'s response to the AESO information request dated September 6, 2017.
4. Referral from the AESO to the MSA dated September 13, 2017.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
