EVENT DETAILS

On January 7, 2017 during the HE 23 settlement period, the ENCG asset was dispatched to provide 14 MW of supplemental reserves load (SUPL). At 22:20 ENCG received an ancillary services directive to reduce load by 14 MW. Ten minutes following the directive, the reduction in load from ENCG was less than the directed amount. ISO rule section 205.6 indicates that a pool participant must ensure that after receiving a directive to provide supplemental reserve, the asset is providing the quantity of real power equal to the instantaneous amount of real power of the asset at the time of the directive plus the amount of real power set out in the directive, no later than ten minutes after receiving the directive.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 205.6.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO generation and dispatch data for ENCG for January 7, 2017.
2. Self-report from EnerNOC Ltd. to the MSA dated January 31, 2017.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
