EVENT DETAILS

On October 16, 2018 at approximately 07:47, an offer was submitted for asset ESBC to import 50 MW in the hour ending (HE) 11 to 13 settlement intervals on the same day. However, the sum of the e-tag import volumes for the start of the HE 11 settlement interval was 75 MW. A corresponding restatement was submitted to revise the import offers to 75 MW for HE 11 to 13 at approximately 10:34. Subsection 6(3) of section 203.6 of the ISO rules states:

A pool participant must submit one (1) or more e-tags for an energy interchange transaction such that the final total amount in MW agrees with the available capability of the single source asset:

- (a) as stated two (2) hours prior to the start of the settlement interval; or
- (b) as may be restated in accordance with the provisions of this section 203.6, but in any event the final total amount in MW must not exceed the available capability of the single source asset as stated at two (2) hours prior to the start of the settlement interval.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 203.6.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. E-tag data and AESO import offer data for ESBC for October 16, 2018.
2. Self-report submitted by TransCanada Energy Sales Ltd. to the MSA dated November 9, 2018.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
